# Translation and interpretation



<b>Translation (Rate per word) <sup>3)</sup></b> Spanish<->English German<->Spanish German<>English French into Spanish, English or German	\$0.29 - \$0.32 <sup>4)</sup>
<b>Hourly rate</b>	\$100
<b>Consecutive Interpretation (escort, community interpreting, health care interpreting in the U.S., simultaneous interpreting ) by a master-level Spanish-language court certified interpreter (by the Supreme Court of Nevada)</b> Note: Two-hour minimum for Spanish and German interpreting services. Cancellations must be received five days prior to the assignment.	\$80 -- \$125/hour - plus mileage and preparation time
<b>24 hour service</b> 10 pages max. <b>48 hour service</b> Translations exceeding 10 pages within 48 hours (20 pages max)	Additional charge 100%

<b>24 hour service</b>	Additional charge 100 %
